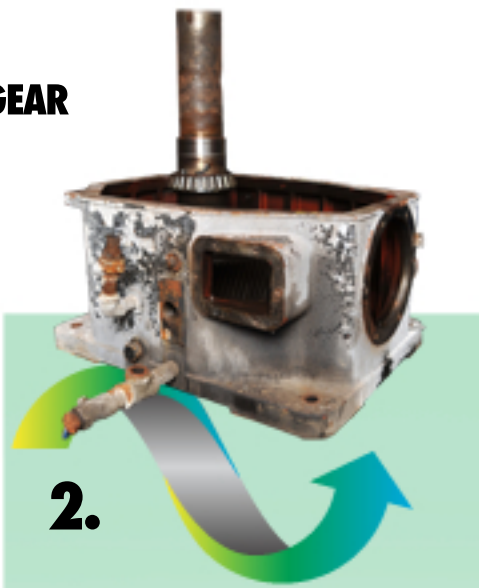


RENEWING YOUR AMARILLO® GEAR



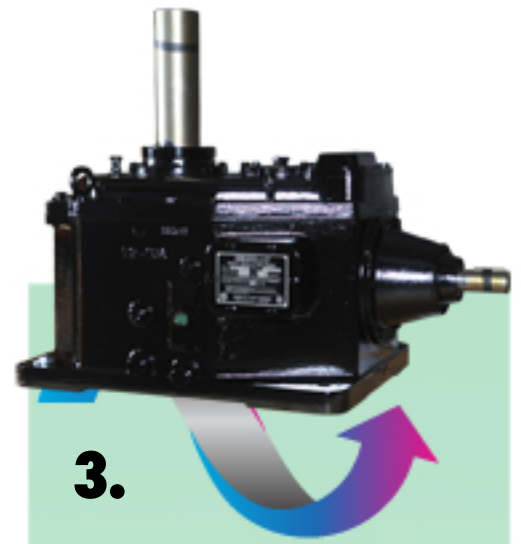

When you contact Amarillo® Gear Company about RENEWING your drive, we will send you a *Not To Exceed* quote to give you an idea of the potential total cost of RENEWAL.

After receiving your drive, an Amarillo® Gear Technician will inspect for wear and damage. Many times there are parts that can be cleaned and reused providing you, the customer, with considerable cost savings. You will then receive an *As Found Condition Report*, photographs and an updated quote.

Finally, after your approval, your drive will be **RENEWED**, inside and out, tested, painted and returned to you with an *As New* one year warranty.

RENEWALS

Not To Exceed Renewal Quote

Not To Exceed renewals will include an *As Found Inspection Report* with photographs, disassembly/reassembly labor, pressure wash gear housing interior, spiral bevel gears, helical gear and pinion, vertical output shaft, new bearings, seals, shims, o-rings, external hardware, setting gear clearances, a no load spin test, mineral oil, sandblast, and original factory paint.

Gears & Shafts

Gears and shafts can be reused based on visual inspection allowing the savings to be deducted from the original quote. For additional assurance we can perform magnetic particle inspection which will detect hair line cracks not visible to the naked eye (additional fee).

Workmanship

All inspections and repairs are performed by our skilled Technicians in our ISO Certified renewal facility. You will receive the same attention to detail and quality workmanship that you have come to expect from Amarillo Gear Company for over 75 years.

Shipping

Amarillo Gear can arrange for pick up at your site.

Warranty

All gearboxes renewed by Amarillo Gear Company will receive a new one year factory warranty.

Limited Warranty

Amarillo Gear Company LLC ("Amarillo") warrants that the Amarillo Right Angle Fan Drive ("Product") will be free from defects in material and workmanship for a period ending on the earlier to occur of twelve months from the date of installation or eighteen months from the date of shipment from Amarillo's renewal facility.

This Limited Warranty shall be void if the Product is not installed, operated, serviced and maintained in accordance with Amarillo's published instructions for the Product or if transmitted loads are not within the published limits for the Product. In addition, this Limited Warranty shall be void if the Product is in any way subjected to; (i) improper storage; (ii) accident, damage, abuse or misuse; (iii) abnormal operating conditions or applications; or (iv) repair or modification by Buyer or any third party without the prior written consent of Amarillo.

In no event will Amarillo be liable, whether in tort, contract or otherwise, for any bodily injury, death or property damage resulting from or in any way arising out of any goods or services provided by Amarillo or the Product. IN NO EVENT SHALL AMARILLO BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, LOSSES, OR EXPENSES.

No change in any provision in this Limited Warranty may be made without the prior written agreement of an authorized officer of Amarillo.
